Hello!

We have exciting news; Spring Fling is back in 2022!

So, join the **Foxton Tourism and Development Association** for the **2022 Foxton Spring Fling**, in Main Street Foxton. Spring Fling will run from **9am to 3pm on Sunday of Labour Weekend – 23th October 2022.**

Not only are we running Spring Fling we are also planning **Merry Main Street on Sunday 11th December** from **9am to 3pm** in **Foxton Main Street**. We are providing our stall holders with the opportunity to grab a concession price for both events or register for just the one. The concession price is noted on the registration form.

If you would like to register for both Spring Fling and Merry Main Street, please complete the registration form and fill out the concession price but if you would only like to attend Spring Fling please complete with the regular price.

Our rules and guidelines that follow will be the same for both the Spring Fling and Merry Main Street unless otherwise stipulated.

We would like to take this opportunity to thank all of our stall holders for being patient with us as we spent last year navigating our way through COVID-19 and the cancellation of our events.

Rules and Regulations

Guidelines:

- Stall holders must be on site no later than 8:00am for set up. Food stalls need to be on site by 7:30am to ensure we have power to your site. There will be someone on site from 6:00am to direct you to your location. If you are late, you will be refused entry!
- No stall holder may drive in Main Street until 4:00pm as this road is **CLOSED!**
- No stall may be dismantled prior to 3pm, as the road reopens at 4pm. This is health and safety requirement. After 4pm, all vehicles must move slowly when within the market and follow all instructions from site marshals'.
- Due to Work Safety and courtesy for the other stallholders, there are limited spaces where you can use a generator. If you require power for your site, please advise on the application form.
- Stallholder vehicles may be allowed to park within the boundaries of your site (dependent on where you are located, you will be advised before the day) providing you are not impinging on neighboring sites, and you cause no disruption to other stalls.
- There is no postponement day – the Spring Fling and Merry Main Street will go ahead no matter the weather and there will be no refunds for.
- The Spring Fling and Merry Main Street are not a garage sale. FTDA reserves the right to refuse stalls.

Food Stalls:

- The organising committee reserve the right to limit the number of similar food stalls to ensure there is a wide selection of food on offer.
- If you are selling food, **you must** have a certificate from Horowhenua District Council. **No Certificate – no food sales!** They do send inspectors around on the day to check. Please check out their website <http://www.horowhenua.govt.nz> or contact the Environmental Health Officer at the council by phoning (06) 366 0999 or email enquiries@horowhenua.govt.nz.

COVID-19:

- The FTDA will adhere to all current government guidelines regarding COVID-19. There will be QR codes available on all gates into Spring Fling along with locations through the event as well. Should Spring Fling or Merry Main Street need to be cancelled due to government announcement, we will make contact with you as soon as decisions are made by the FTDA.

Payment:

- Site fees must be paid no later than **Friday 7th October 2021**, there will be **NO** payments allowed on the **day of Spring Fling** . If you have not paid for your site by the above date, your stall will not be confirmed, and your site will be reallocated. Site plans and regulations for the day will be sent out to confirmed stall holders no later than **Monday 17th October, 2021**.
